

## Facebook CTF 2019 Contest Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE IN THIS PROMOTION. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

INTERNET ACCESS AND A VALID EMAIL ADDRESS ARE REQUIRED.

POTENTIAL WINNERS/WINNING TEAMS WILL BE REQUIRED TO RESPOND TO AN INITIAL NOTIFICATION FROM SPONSOR (DEFINED BELOW) WITHIN FORTY-EIGHT (48) HOURS AND WILL ALSO BE REQUIRED TO EXECUTE PRIZE ACCEPTANCE DOCUMENTS AND RETURN THEM WITHIN FOURTEEN (14) DAYS FROM THE DATE THEY ARE SENT, AS MORE FULLY DETAILED BELOW.

IMPORTANT: PLEASE READ THESE OFFICIAL RULES, WHICH ARE A CONTRACT, CAREFULLY BEFORE TAKING ANY STEPS TO PARTICIPATE. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SPONSOR FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES. BY PARTICIPATING, YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES AND REPRESENT THAT YOU SATISFY ALL OF THE ELIGIBILITY REQUIREMENTS.

### (1) OVERVIEW:

The Facebook CTF 2019 Contest (“**Promotion**”) is sponsored by Facebook, Inc (“**Sponsor**”). From 5:00:00 p.m. U.S. Pacific Time (“PT”) on May 31, 2019 until 5:00:00 p.m. PT on June 2, 2019 (“**Promotion Period**”), qualifying individuals can visit fbctf.com (“**Website**”) to register for the Promotion and participate individually or as a team by solving computer science and cyber security puzzles, and submitting flags to earn points. After solving a puzzle, a qualifying individual can submit the answer (or “flag”) to Facebook as set forth in more detail in the HOW TO ENTER section below to earn points (“**Points**”) for that individual (if competing individually) or that individual’s team (if competing on a team) in this Promotion (the qualifying individuals are collectively, “**Participants**” and each, a “**Participant**”, and teams comprised of Participants are collectively, “**Teams**” and each, a “**Team**”). These Official Rules (“**Official Rules**”) govern the participation in the Promotion as indicated by Sponsor’s linking to these Official Rules in Promotion-related materials or correspondence. Following the Promotion Period, Participants/Teams who earn the most Points will be the potential winners of a prize in this Promotion, subject to verification. **This is only a high-level summary of the Promotion; read through these entire Official Rules to make sure you understand the details.**

### (2) ELIGIBILITY:

This Promotion is open only to legal residents within the Territory (defined below) who, as of the start of the Promotion Period: (i) are at least eighteen (18) years of age and the age of majority in their state or jurisdiction of residence; and (ii) have Internet access and a valid email address throughout the Promotion Period. “**Territory**” means any country, state, or province where the laws of the United States or local law do not prohibit participating or receiving a prize in the Promotion and excludes Kenya, Venezuela, Argentina, Greece, Italy, Brazil, Quebec, Cuba, Iran, North Korea, Sudan, Myanmar/Burma, Syria, Zimbabwe, Iraq, Lebanon, Liberia, Libya, Somalia, Zimbabwe, Burma, Belarus, Balkans, and any other jurisdiction or area designated by the United States Treasury’s Office of Foreign Assets Control. Eligible Participant’s email address may indicate that the individual is associated with or an employee of a company/business/organization (any, a “**company**”), but each Participant represents and warrants that they are participating in this Competition in their individual capacity and not on behalf of their company and that their actions do not violate their company’s policies and procedures.

Employees, officers, directors, members, managers, agents, and representatives of the Sponsor or its parent and subsidiary companies, affiliates, divisions, representatives, consultants, sub-contractors, suppliers, distributors, legal counsel, prize providers, contest administrators, advertising, public relations, promotional, fulfillment and marketing agencies (collectively, the “**Released Parties**”) and members of their immediate families (defined for these purposes as including spouse, domestic partner, parents, legal guardian, legal ward, children, and siblings and each of their respective spouses) and individuals living in the same household as such individuals, are not eligible. Participation in this Promotion constitutes Participant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor.

### (3) HOW TO PARTICIPATE:

During the Promotion Period, qualifying individuals are invited to register for the Promotion by visiting the Website and completing and submitting in full the registration form with all required information. Participants can elect to participate individually or, during the registration process, can elect to create or join a Team. To create a Team, the individual will be asked to create a name for the team and a secret code that can be used by others to join the Team. To join a Team, you must have the Team’s secret code and input the secret code when prompted during the registration process. There is no limit on the size of the Teams, however each Participant may only participate on a single Team or in their individual capacity. For the avoidance of doubt, a Participant may not participate both as an individual and on a Team, and a Participant may not participate on more than one Team. Participants participating on Teams are

responsible for safeguarding their Team's secret code. Sponsor has no responsibility for misuse of or unauthorized activity associated with Team secret codes.

After registering, Participants have the opportunity to solve puzzles presented on the Website. After correctly solving a puzzle, Participants can submit the puzzle flag (and any other information required by Sponsor) in accordance with the instructions provided by Sponsor on the Website to earn points (each flag, and all content or other material submitted with such flag, may be referred to collectively as a "**Submission**"). Participants will earn points for Submissions submitted and received during the Promotion Period in accordance with these Official Rules. For Participants participating on a Team, the points will be credited to the Team.

Point allocations for each puzzle will depend upon the number of Participants/Teams that submit the flag for that puzzle during the Promotion Period, with higher points values being awarded for those puzzles that are more difficult (i.e. solved by lower numbers of Participants). As such, final point totals will not be calculated until the close of the Promotion Period. There is a limit of one Submission per Participant/Team for each puzzle.

Following the end of the Promotion Period, the Participants or Teams with the highest cumulative point totals will be deemed the potential winners, as set forth in more detail in the WINNER SELECTION AND NOTIFICATION section below. Any questions or disputes with respect to point totals will be resolved by Sponsor and Sponsor's decisions are final.

**All Submissions must comply with all of the Submission Requirements detailed in Section 4 below.** Participants are not permitted to share flags and Sponsor reserves the right to disqualify Participants engaging in sharing (including both those who share a flag and those who receive the shared flag). Participants are prohibited from accessing or altering other Participants' information, point totals or Submissions, or brute forcing flags, and any attempt to engage in these activities, whether or not successful, may result in immediate termination from the Program and all Points accrued by the terminated individual on either platform will be void. Attempts made by an individual to participate in excess of any stated limit are void and persons engaging in such conduct may, in Sponsor's sole discretion, be disqualified. Flags must be submitted by Participant to Sponsor during the Promotion Period in strict accordance with the instructions and restrictions in these Official Rules and any other instructions that Sponsor may provide through its authorized representatives or otherwise. Participation, including any Submission, that is not actually received by Sponsor and its representatives will not be considered for the Promotion. Purported proof of participating (such as, without limitation, a screenshot of the flag or your purported participation) does not constitute proof of actual participation for purposes of this Promotion. Purported participation that is incorrect or incomplete, received outside the Promotion Period, or contains obscene, offensive, or any other language, code or imagery communicating messages inconsistent with the positive images with which Sponsor wishes to associate itself (all as determined by Sponsor in its sole discretion) will be void. Those who do not abide by these Official Rules and the instructions of Sponsor and its representatives and provide all required information may, in Sponsor's sole discretion, be disqualified and any purported participation by such person an/or related squad void, even if other squad members complied. Participation that is fraudulent, forged, altered, incomplete, lost, late, misdirected, mutilated, illegitimate, incomprehensible, garbled, or generated by a macro, bot, or other automated means will not be accepted and will be void. Participation made by someone on behalf of any other individual or any entity or group, made by another on your behalf, or originating at any online service other than as specifically described above (including, without limitation, through a commercial promotion subscription, notification, or entering service) will be declared invalid and disqualified for this Promotion. As a condition of participating in the Promotion, without limiting any other provision in these Official Rules, each Participant gives consent for Sponsor and its agents to obtain and deliver their name, address, and other information and content to third parties for the purpose of administering this Promotion and complying with applicable laws, regulations, and rules. **YOU SHOULD RETAIN A COPY OF YOUR SUBMISSION AND RECORDS OF YOUR PARTICIPATION. SPONSOR IS NOT RESPONSIBLE FOR PROVIDING A COPY OR REPORT OF ANY ELEMENT OF PARTICIPATION.**

#### **(4) SUBMISSION REQUIREMENTS:**

Submissions must meet all of the following requirements, as determined by Sponsor in its sole discretion, or the associated participation may be disqualified:

- When submitting flags, Participants must provide all required information at the time of submission.
- Submission must not infringe, misappropriate, or violate any rights of any third party including, without limitation, copyright (including moral rights) and patent.
- Submission must not include any malware, spyware, viruses or similar harmful code or content.
- Submission must not contain or describe any harmful or illegal activity or content or in any way violate any federal, state, provincial or local laws, rules, or regulations.

**You agree that your participation in this Promotion and agreement to these Official Rules will not violate any agreement to which you are a signatory or party and that no such agreement otherwise limits your ability to participate in this Promotion or grant the rights granted by you in these Official Rules.**

Sponsor reserves the right in its sole discretion to disqualify your Submission or you from the Promotion if in Sponsor's sole

discretion your Submission does not comply with these requirements or if you do not comply with any other requirement of these Official Rules.

**(5) WINNER SELECTION/NOTIFICATION:**

At the conclusion of the Promotion Period, potential winners will be determined based upon the point totals accrued by each Team or individual Participant, with the three (3) individual Participants or Teams earning the highest number of points deemed potential winners subject to verification.

In the event of a tie, the first Team or individual Participant to reach the tying point value will be deemed the potential winner, subject to verification.

FAILURE TO TIMELY RESPOND OR COMPLETE ANY OF THE STEPS SET FORTH IN THE NOTIFICATION PROCEDURES BELOW FOR ANY REASON, INCLUDING FILTERING OR FAILURE BY ANY POTENTIAL WINNER TO NOTICE OR ACCEPT A COMMUNICATION FROM SPONSOR OR ITS REPRESENTATIVE, MAY RESULT IN DISQUALIFICATION OF SUCH POTENTIAL WINNER AND SELECTION OF AN ALTERNATE WINNER. Sponsor reserves the right to contact Participants for verification purposes and administration of the Promotion. All Sponsor's decisions are final and binding in all matters relating to this Promotion. Each Participant acknowledges that the winner determination will be made within approximately two (2) days from the end of the Promotion Period, and then Sponsor will contact the potential winners via email or Internet Relay Chat (IRC). If a potential winner is a Team, Sponsor will reach out to all Individuals on the Team who must then identify amongst themselves one Individual on the Team who will serve as the Team captain ("Team Captain") who will be responsible for completing the winner verification and prize fulfillment process, including distribution of prize amounts to all Team members, as set forth in these Official Rules. Potential winners will be required to respond to Sponsor as instructed in the email within forty-eight (48) hours of initial notification. If a Team, response must indicate Team Captain.

Each potential winner (including each Participant on a potentially winning Team) will, in Sponsor's sole discretion, be required to complete, sign, notarize (if applicable), and return, without alteration and in the form presented by Sponsor, an affidavit of eligibility and liability/publicity release and tax forms (as applicable) (collectively, the "**Winner Documents**") according to Sponsor's instructions within fourteen (14) days from when Sponsor sends the Winner Documents or other time frame as specified by Sponsor or its representative. Winner Documents will be distributed to the Team Captain (if applicable) and the Team Captain will be responsible for distributing Winner Documents to all Team members and for collecting completed Winner Documents from Team members and submitting the Winner Documents to Sponsor in accordance with Sponsor's instructions. Sponsor is not responsible for any failure to return Winner Documents for Team members and such failure may result in forfeiture of prize by Individual or Team. Sponsor shall have no responsibility for the security or safeguarding of any information provided in the Winner Documents while in any Individual or the Team Captain's possession. Failure to comply with these requirements, Sponsor's or its representative's instructions, or these Official Rules may, in Sponsor's sole discretion, result in disqualification from the Promotion and forfeiture of any prize potentially won. The Winner Documents are each subject to verification by Sponsor and may require the Participant to provide their Social Security Number or other identification number and/or a copy of government-issued identification card or number therefrom. Tax documents as may be required in an applicable jurisdiction may be issued as appropriate in Sponsor's sole discretion. If any prize, prize notification, or other Promotion-related communication is returned as undeliverable or if a selected potential winner cannot be reached or does not respond as instructed after Sponsor has attempted to notify that potential winner, that selected winner may be disqualified and an alternate winner may be selected (time permitting and in Sponsor's sole discretion). Sponsor reserves the right to modify the notification procedures in connection with the selection of any alternate potential winner, if any. The prize claim and Prize Winner Documents are subject to verification by Sponsor. The prize, if legitimately claimed, will be awarded. Sponsor will not be obligated to pursue more than two (2) alternate winners (time permitting) for any reason.

**(6) PRIZE, QUANTITY & APPROXIMATE RETAIL VALUE ("ARV"):**

First Place: \$3,133.70 USD

Second Place: \$2,000 USD

Third Place: \$1,000 USD

Prizes will be awarded to winning Participant or Team Captain through the HackerOne platform. A HackerOne account is required to receive prize payout and requires consent to the HackerOne Terms and Conditions which can be accessed at: <https://www.hackerone.com/terms>.

Team Captains receiving prizes, if any, are responsible for equitably distributing the prizes to all members of the Team. Sponsor shall have no liability for the prize after it has been distributed to the Team Captain and is not responsible for the Team Captain's actions with respect to the prize money and distribution.

Total ARV of all prizes: \$6,133.70 USD.

If a winner cannot receive a prize from Sponsor per such winner's employer's policies, such winner will forfeit the prize won and Sponsor will have no further obligation to that winner. Any taxes (federal, state, provincial, and local) and other costs and expenses associated with prize acceptance or use and not specified in these Official Rules as being part of the prize will be the sole responsibility of winner, or, in the event the prize awarded to a Team, will be the sole responsibility of the Team Captain. Winner may be issued a tax form for the actual value of the prize. No more than the stated prize will be awarded. Sponsor will not replace any lost, mutilated, or stolen prizes or prize elements or any prizes that are undeliverable or do not reach the winner because of an incorrect or changed address or contact information. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited and Sponsor will have no further obligation with respect to that prize or portion of the prize. No transfers, prize substitutions, or cash redemptions will be made, except at Sponsor's sole discretion. Any mailed prize elements will only be mailed or otherwise provided to the verified winner's address in the Territory, unless Sponsor, in its sole discretion, agrees otherwise. Sponsor reserves the right to substitute any prize or portion thereof with another prize or portion thereof of equal or greater value for any reason, including unavailability of the stated prize. Each Participant waives the right to assert as a cost of winning any prize any and all costs of verification and redemption or travel to claim the prize and any liability and publicity which might arise from claiming or seeking to claim said prize.

**(7) LIMITATION OF LIABILITY AND DISCLAIMER OF WARRANTIES:**

**NOTHING IN THESE TERMS LIMITS, EXCLUDES, OR MODIFIES OR PURPORTS TO LIMIT, EXCLUDE, OR MODIFY ANY STATUTORY CONSUMER GUARANTEE OR ANY IMPLIED CONDITION OR WARRANTY, THE EXCLUSION OF WHICH FROM THESE TERMS WOULD CONTRAVENE ANY STATUTE OR CAUSE ANY PART OF THESE TERMS TO BE VOID ("NON-EXCLUDABLE GUARANTEES"). SUBJECT TO THE LIMITATIONS IN THE PRECEDING SENTENCE AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, EACH PARTICIPANT AGREES TO RELEASE, HOLD HARMLESS, AND INDEMNIFY EACH OF THE RELEASED PARTIES FROM AND AGAINST ANY LIABILITY WHATSOEVER FOR INJURIES OR DAMAGES OF ANY KIND SUSTAINED IN CONNECTION WITH THE ACCEPTANCE, USE, MISUSE, OR AWARDED OF THE PRIZE OR WHILE PREPARING FOR, PARTICIPATING IN, AND/OR TRAVELING TO OR FROM ANY PRIZE- OR PROMOTION-RELATED ACTIVITY INCLUDING, WITHOUT LIMITATION, ANY INJURY, DAMAGE, LOSS, DEATH OR ACCIDENT TO OR OF PERSON OR PROPERTY. THE PRIOR LIMITATION ON DAMAGES IS NOT INTENDED TO LIMIT THE RELEASED PARTIES' OBLIGATION (IF ANY) TO PAY PREVAILING PARTY COSTS OR FEES IF RECOVERABLE PURSUANT TO APPLICABLE LAW. THE LIMITATIONS SET FORTH IN THIS SECTION WILL NOT LIMIT OR EXCLUDE THE RELEASED PARTIES' LIABILITY FOR PERSONAL INJURY OR TANGIBLE PROPERTY DAMAGE CAUSED BY THE RELEASED PARTIES, OR FOR THE RELEASED PARTIES' GROSS NEGLIGENCE, FRAUD, OR INTENTIONAL, WILLFUL, MALICIOUS, OR RECKLESS MISCONDUCT. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, EACH WINNER AGREES THAT THE PRIZE IS PROVIDED AS-IS WITHOUT ANY WARRANTY, REPRESENTATION, OR GUARANTEE, EXPRESS OR IMPLIED, IN FACT OR IN LAW, WHETHER NOW KNOWN OR HEREINAFTER ENACTED, RELATIVE TO THE USE OR ENJOYMENT OF THE PRIZE, INCLUDING, WITHOUT LIMITATION, ITS QUALITY, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE, BEYOND ANY NON-EXCLUDABLE GUARANTEES.**

**EACH PARTICIPANT UNDERSTANDS AND AGREES THAT ALL RIGHTS UNDER SECTION 1542 OF THE CIVIL CODE OF CALIFORNIA AND ANY SIMILAR LAW OF ANY STATE OR JURISDICTION OF THE UNITED STATES ARE HEREBY EXPRESSLY WAIVED BY THEM. SECTION 1542 READS AS FOLLOWS:**

**"CERTAIN CLAIMS NOT AFFECTED BY A GENERAL RELEASE. A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY."**

**(8) DISPUTES/GOVERNING LAW:**

Except where prohibited, as a condition of participating in this Promotion, each Participant agrees that any and all disputes that cannot be resolved between the Participant and any Released Party, claims and causes of action arising out of or connected with this Promotion, or the prize awarded, or the determination of a winner must be resolved individually, without resort to any form of class action. Further, in any such dispute, under no circumstances will a Participant be permitted or entitled to obtain awards for, and hereby waives all rights to claim punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than Participant's actual out-of-pocket expenses (if any), not to exceed ten dollars (\$10), and Participant further waives all rights to have damages multiplied or increased.

ANY LEGAL ACTIONS, SUITS, OR PROCEEDINGS RELATED TO THIS PROMOTION (WHETHER FOR BREACH OF CONTRACT, TORTIOUS CONDUCT, OR OTHERWISE) WILL BE BROUGHT EXCLUSIVELY IN THE U.S. DISTRICT COURT FOR THE NORTHERN DISTRICT OF CALIFORNIA OR A STATE COURT LOCATED IN OR HAVING JURISDICTION OVER SAN MATEO COUNTY, CALIFORNIA AND EACH PARTICIPANT IRREVOCABLY ACCEPTS, SUBMITS, AND CONSENTS TO THE EXCLUSIVE JURISDICTION AND VENUE OF THESE COURTS WITH RESPECT TO ANY LEGAL ACTIONS, SUITS, OR PROCEEDINGS ARISING OUT OF OR RELATED TO THIS PROMOTION. YOU WAIVE ANY AND ALL OBJECTIONS TO JURISDICTION AND VENUE IN THESE COURTS AND HEREBY SUBMIT TO THE JURISDICTION OF THOSE COURTS.

**(9) ADDITIONAL DISCLAIMERS:**

The Released Parties are not responsible and/or liable for any of the following, whether caused by a Released Party, the Participant, or by human error: participation submitted by illegitimate means (such as, without limitation, by an automated computer program) or participation in excess of any stated limit; any lost, late, incomplete, illegible, unintelligible, garbled, mutilated, or misdirected participation, email, mail, or Promotion-related correspondence or materials or postage-due mail; any error, omission, interruption, defect or delay in transmission or communication; viruses or technical or mechanical malfunctions; interrupted or unavailable cable or satellite systems; errors, typos, or misprints in these Official Rules, any Promotion-related advertisements, or other materials; failures of electronic equipment, computer hardware, or software; lost or unavailable network connections or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications or participation information. Released Parties are not responsible for electronic communications that are undeliverable or do not reach Participant as a result of any form of active or passive filtering of any kind (including, without limitation, messages from Sponsor that are segregated into an "Other" or similar folder) or insufficient space in a potential winner's email or voicemail inbox to receive email or voicemail messages. Released Parties are not responsible, and may disqualify you, if your email address or other contact information does not work or is changed without prior written notice to Sponsor. Without limiting any other provision in these Official Rules, the Released Parties are not responsible or liable to any Participant or winner (or any person claiming through such Participant or winner) for failure to supply the prize or any part thereof in the event that any of the Promotion activities or Released Parties' operations or activities are affected by any cause or event beyond the sole and reasonable control of the applicable Released Party (as determined by Sponsor in its sole discretion), including, without limitation, by reason of any force majeure event, equipment failure, threatened or actual terrorist acts, air raid, act of public enemy, war (declared or undeclared), civil disturbance, insurrection, riot, epidemic, fire, explosion, earthquake, flood, hurricane, unusually severe weather, blackout, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, any law, rule, regulation, action, order, or request adopted, taken, or made by any governmental or quasi-governmental entity (whether or not such governmental act proves to be invalid), or any other cause, whether or not specifically mentioned above.

**(10) GENERAL RULES:**

By entering the Promotion (except where prohibited by law), each Participant grants the Released Parties the irrevocable, sublicensable, free-of-charge, absolute right and permission to use, publish, post or display their name, photograph, likeness, voice, biographical information, any quotes attributable to them, and any other indicia of persona (regardless of whether altered, changed, modified, edited, used alone, or used with other material in the Released Parties' sole discretion) for advertising, trade, promotional and publicity purposes without further obligation or compensation of any kind to them, anywhere worldwide, in any medium now known or hereafter discovered or devised (including, without limitation, on the Internet) without any limitation of time and without notice, review or approval, and each such person releases all Released Parties from any and all liability related to such authorized uses. In addition each Participant that enters in association with a company/business further, on behalf of the company/business grants to the Released Parties (and their agents, successors, and assigns) a non-exclusive, irrevocable, worldwide, transferable and sublicensable right and license to use such company/business's trade names and trademarks (including logos) in connection with this Promotion and the promotion and marketing of Sponsor.
